Reference Checking and Background Investigations: I hereby give the Council on Aging the right to make a thorough investigation of my past employment, education, activities and credit history. I understand that the results of any such investigation may be used to make decisions concerning my employment. I release and indemnify the Council on Aging against any liability which might result from making such an investigation. I UNDERSTAND THAT ANY FALSE ANSWER OR STATEMENTS OR IMPLICATIONS MADE BY ME IN THIS APPLICATION OR OTHER REQUIRED DOCUMENTS, MAY RESULT IN DENIAL OF EMPLOYMENT OR SUBSEQUENT DISCHARGE. I further understand and agree that the results of any investigation may be communicated to the Council on Aging, and any others it deems appropriate.

Employment at Will I understand that my employment status is "at will" and, that the Council on Aging reserves the right to terminate my services at any time, with or without notice, with or without cause. Furthermore, I understand that nothing contained in this employment application, or in the granting of an interview, is intended to create an employment contract between the Council on Aging and myself for either employment or for the providing of any benefits. No promises regarding employment have been made to me and I understand that no such promise or guarantee is binding upon the Council on Aging unless made in writing by the Chief Operating Officer or his/her authorized representative.

Employment Eligibility Verification I understand that any offer of employment is conditioned on my ability to establish my identity and eligibility for employment in the United States.

Drug Testing As a prerequisite to employment, I hereby agree to allow the Council on Aging to collect urine samples from me to determine the presence of illegal drugs in my body. Further, I give my consent to the release of my test results to authorized Agency management for appropriate review.

SUMMARY

Perform those Homemaker Personal Care and Respite activities contained in the Service Plan Agreement, by performing the following duties.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following. Other duties may be assigned.

1. Assist client with personal hygiene, dressing, feeding, transferring or ambulating. Provide supervision and companionship in order to relieve the primary caregiver for a specific period of time, while complying with Agency policy and Service Plan Agreement.
2. Assist with food, nutrition and diet activities, including preparation of meals when required and purchase of food and other items for the client's care.
3. Will perform light housekeeping services as prescribed by the service plan while communicating any suggested changes to their supervisor or a Case Manager.
4. Maintain all required paperwork, including service sheets, with clarity; and accuracy and submit them on a timely basis.
5. Attend all required meetings, seminars and workshops that may enhance job performance.
6. Do not deviate from any policies or procedures, which may be relayed from time to time, without the expressed consent of a supervisor.
7. Use personal protective equipment as required.

SUPERVISORY RESPONSIBILITIES:

This job has no supervisory responsibilities.

QUALIFICATIONS:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required.
